State of New Mexico 2020 Census

- New Mexico Population 2,117,522, source census.gov
- 10 year growth rate 2.8%, national growth rate 7.4%
- NM has five counties that account for 1,321,323
 - Bernalillo, Santa FE, Dona Ana, Sandoval, San Juan
- 47.7% of the population identifies as latino or Hispanic
 - This is the largest of any state
 - New Mexico ranks third in native American or indigenous people
 - Alaska and Oklahoma rank 1 and 2 respectively

Medicaid and Medicare

- NM Total 2,117,554
- People on Medicaid, Dec, 2023 804,856, includes CHIPS program
 - In order to qualify for Medicaid, one must meet 1 of 8 poverty criteria.

New Mexico Workforce

- 2022 818,800 employees received a W2 https://www.dws.state.nm.us/Researchers/Data/Occupations-Wages
- 180,400 are government employees, State, County, Municipal, Federal
- 49,200 Education
- 47,400 Health Care + 53,780 Health Care support 101,180
 Total
- 180,400+ 49,200+47,400+53,780=330,780 Government, Education, Health Care, and Health Care support.
- 818,800 330,780 = 488,020 non-government, education or health care.
- 488,020 / 2,117,522= 23% of population to fund NM government

23% of population is left to fund NM government.
